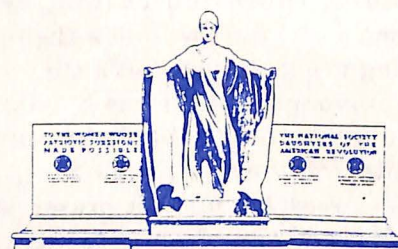

After completing the first year for this committee, we are indeed encouraged by the positive response of our membership to increase our involvement in programs which are promoting adult literacy. Our thrust is limited to functionally illiterate adults: those who are unable to read, write, speak or otherwise communicate competently enough to meet the demands of modern society.

Three areas form our focus of attention:

- (1) "Search and Rescue": Encouraging members to find those adults who need to be helped to take advantage of available adult literacy programs.
- (2) "Each One Teach One": Encouraging members who are willing to become tutors.
- (3) "FUNd Raising": Encouraging local chapters to raise or donate funds to promote existing adult literacy programs. Such funds are to be used locally and are not to be sent to the Treasurer General.

A detailed questionnaire will be mailed early next year to each state chairman. The basic information which will be requested is as follows:

- (1) Please estimate the number of members in your state who are involved in some literacy program. How are they involved (literacy committee, tutor, etc.)?
- (2) How much financial assistance was provided to adult literacy programs in your area? How was this done (fund raisers, donations, etc.)? How were the funds used?
- (3) Was a program on adult literacy/Literacy Challenge Committee presented to each chapter? Please describe any outstanding programs.
- (4) What specific steps were taken to involve your membership?
- (5) If possible, please relate a situation in which one of your members was able "To Make a Lasting Difference" in the life of an adult learning to read.

Who are these adults we seek to help through our Literacy Challenge Committee? Some want to read bedtime stories to their children. Some want to read a newspaper. Most want to read The Bible. Some had to drop out of school to help support families. Some are new citizens wanting to learn the language of this land of opportunity--much as many of our ancestors did. Whoever they are--whatever their hopes--I would like to pledge to each one that there will be a member of the Daughters of the American Revolution ready to help them achieve their goal.

THE NSDAR ARCHIVES AND THE SPECIAL COLLECTION PERTAINING TO NSDAR HISTORY:

Preparing the Way for the
Centennial Jubilee Celebration
of the NSDAR in 1990

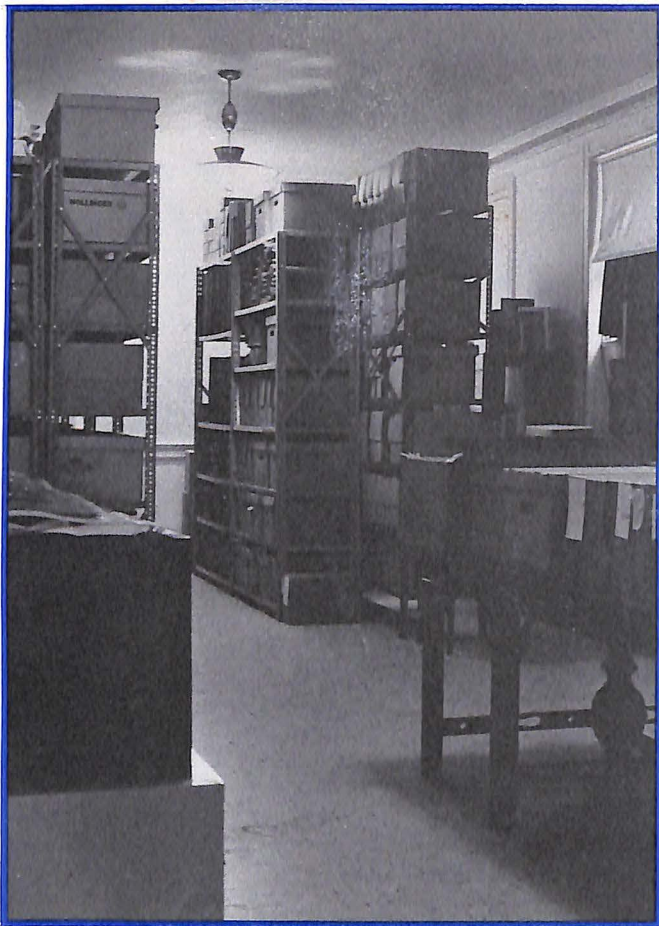

signers of the Declaration of Independence and of all of the signers of the United States Constitution, but one is unable to find the signatures of every woman who has served as President General of the NSDAR, simply because for years the papers of these women were not retained and many now appear to be lost.

Clearly, as the NSDAR prepares for its Centennial Jubilee Celebration in 1990, the need to gather as many documents and

memorabilia as possible that will illuminate the history of one of the oldest and largest women's organizations in the United States is of prime importance. Only if the recently formed NSDAR Archives and the Special Collection pertaining to NSDAR history are significantly nurtured and expanded in the next four and one-half years will the National Society be in a position in 1990 to present a full and accurate picture of its past. With historical details at hand, Daughters throughout the

world, as well as the general public, will become informed of the extensive activities and many good works of this large, multi-faceted organization. In order for the centennial history of the NSDAR to include sufficient, accurate information about NSDAR activities such as its assistance with the establishment of the Army Nurse Corps, the Penny Pines project, immigrants to the United States, the education of children in Appalachia, the strengthening of American history programs in American schools, and aiding French children orphaned during World War I, the National Society is dependent upon its own members and other interested parties to help expand the holdings of the NSDAR Archives and the Special Collection. The following discussion explains exactly what the Archives and the Special Collection are and how one can help strengthen these important collections.

For decades, the NSDAR had no formal repository solely earmarked for preserving papers and memorabilia concerned with the Society's past. Occasionally, interest was shown in the Society's early history, and sporadically Historians General and Assistant Historians General researched the history of the NSDAR, apparently using those records found in nooks and crannies at the National Headquarters and supplementing their information with published records of DAR activities found in the *DAR Magazine*, the annual reports of the NSDAR to the Smithsonian Institution, and the printed histories of the state DAR organizations, which began to be published in the late 1920s. Then, at the time of the Society's Golden Jubilee Celebration in 1940, an "Archives and Document Room" was established. At first located in Memorial Continental Hall, this

room was later relocated on the second floor of the present administration building, and today is known as the Americana Room. However, throughout its forty-five year existence the main use of this room has been as the repository for the Society's early American manuscripts and imprints, which are now referred to as the Americana Collection. Some material focusing on the DAR was stored in this "Archives and Document Room," but only in the 1960s and, in particular, when the NSDAR celebrated its seventy-fifth anniversary was more active interest shown in collecting items emphasizing the organization's own past. The formal establishment of the NSDAR Archives and the Special Collection pertaining to NSDAR history occurred just five years ago, and not until 1983 was an archives policy approved.

Today, the NSDAR Archives and the Special Collection are under the supervision of the NSDAR Archivist, who is directly responsible to the Historian General and implicitly to the Society as a whole. The Archives consists primarily of manuscript, typed, and printed records generated by the offices and the officers of the National Society. These archival records include such items as correspondence, circular letters, memoranda, project case files, committee records, financial data, computer created data, and architectural drawings. The purpose of the Archives is "to collect and preserve the non-current working papers of the National Society, thereby maintaining a permanent record of the functioning of the NSDAR." In contrast to the Archives, the Special Collection contains papers and memorabilia focusing on the Founders, the history, and the accomplishments of the National Society. All holdings in the Archives and the Special Collection are given basic conservation treatment, are arranged in a logical fashion, are inventoried to insure rapid retrieval, and are stored in temperature-controlled, secure rooms. Currently, most items comprising the NSDAR Archives are located in a separate room at National Headquarters. The archives room presently contains approximately 340 linear feet of archival material. Other archival items, such as the NSDAR photograph collection, and the Special Collection, are housed in a portion of the Americana Room.

Considering that for the first ninety years of its existence the National Society had no formal repository for placing its records and lacked a comprehensive plan for collecting archival materials and memorabilia, the NSDAR is fortunate to possess as many records and other items concerning its past as it does, salvaged from closets, desk drawers, file cabinets, and safes at National Headquarters, and donated by devoted and concerned members. Nevertheless, many gaps still exist in the NSDAR Archives, as well as in the Special Collection. Few records have been included to date concerning the work of certain national offices and of most national officers; there are very limited records focusing on the many national committees; and there are almost no programs for the many diverse functions held at Constitution Hall (a significant loss, considering that between 1930 and the opening of the Kennedy Center in 1971 Constitution Hall was the major cultural center in Washington City). Sadly, the list of omissions in the Archives and the Special Collection is long.

With the energetic and dedicated help of every DAR member in the years leading up to the Centennial Jubilee Celebration, hopefully much material needed for the Archives and the Spe-

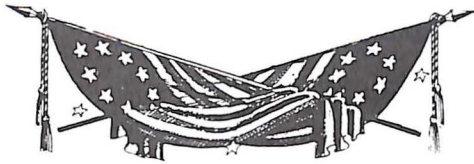

Reports of State Officers, State Chairmen and District Directors are due not later than March 1, 1993. State Officers and State Chairmen report in 200 words or less. District Directors are allowed 250 words. Awards to be made at State Conference should be listed and given to the State Recording Secretary at the time of presentation. A report is expected from each State Officer and State Chairman. Please be prepared.

The directory contained in the front of the *Proceedings* must be kept current. Please send promptly all changes of name and/or address of Chapter Officers to me at the address listed below.

STATE LIBRARIAN

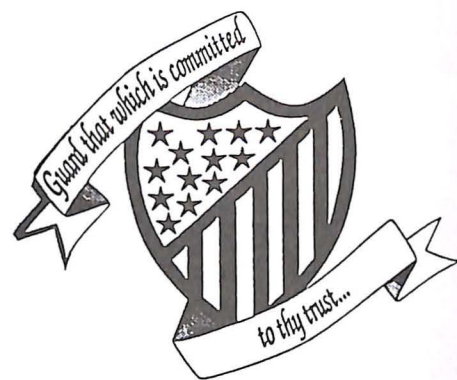
For 97 years the NSDAR Library has served our membership. This year there are added attractions and some important changes connected with the Library.

Give patriotic literature—available are bookmarks with Pledge of Allegiance and Constitution Week, pamphlets and booklets on Flag Code, Star Spangled Banner, the Preamble and other patriotic literature. These will be on display during State Tour. Just place your order and I will gladly send it to you.

The Conservation Committee requests that we all participate in conservation practices at home, in the community, in the schools and in the work place that will have positive effects on preserving this earth for the future.

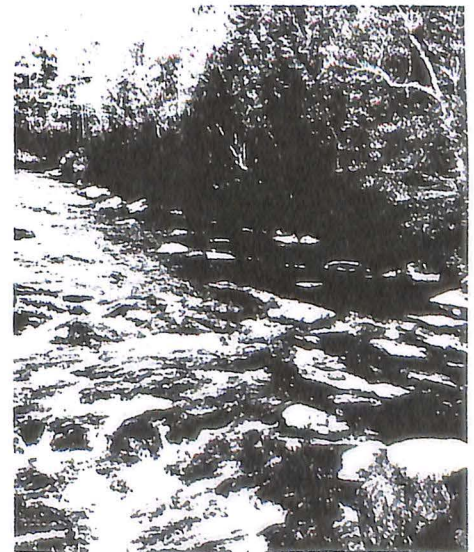

The purpose of the Genealogical Records Committee is to collect unpublished records of a genealogical nature and put them in proper form for use in the DAR Library.

Types of records that you may copy: County and Town deeds and marriages, wills and estates; court orders, books and tax lists; Town Council meetings; parish registers of marriages, births and deaths; vestry minutes or session books; Bible records; school census records; newspaper accounts of births, deaths, and marriages; church records; tombstone inscriptions and cemetery records; funeral home records; family histories, diaries, papers; letters found in manuscript collections in libraries, historical societies and private collections.

Acid-free paper is no longer required but still is preferred. Weyerhaeuser 1st Choice #24 item 1176 should be available through your office supply store.

If a DAR member alone or in conjunction with another person has compiled a book of original records, she may submit this book through the State Chairman rather than directly to the DAR Library and receive GRC credit for Virginia DAR.

Now is the time to start copying your records. Be sure to **index, using full names. Number your pages.**

Send all records to the **State Chairman by December 1.** After checking them, she forwards them to National. *Don't send to National.*

INSIGNIA

The goal of the Insignia Committee is to encourage members to learn all we can about the Insignia, to buy all the pins they are entitled to wear in the correct order on the ribbon and when and where not to wear them.

In the DAR Handbook which contains the Bylaws be sure to read in the Handbook pages 64, 93, 161 through 171; and Article XVI, pages 39 and 40 in the Bylaws.

The official ribbon shall be no longer than 12 inches nor more than three ribbons wide worn at one time. Only pins authorized by the National Board of Management shall be worn on the ribbon. It shall be worn on the left breast and only at functions of the Society or chapter.

When the Insignia is printed it is in the upper center of the page or upper left corner of the page with no printing above it. The Insignia is not to be used on throw-away articles such as cakes, paper napkins, etc.

Have a program on the Insignia, available from the Program Committee.

Honor the DAR Insignia by wearing it correctly and with pride.

DAR Honors Mrs. Hoskins Sclater

The Margaret Lynn Lewis Chapter, Daughters of the American Revolution, Roanoke, Virginia, dedicated its bronze Medallion of Honor, mounted on a 9 inch square stone, on October 2, 1992, in Evergreen Cemetery at the grave of (Mrs. R. Hoskins) Anne Richardson Sclater, a native of Farmville, Virginia. It honors her leadership and outstanding service to the Chapter. During her Presidential term (1943-46) she was its Golden Jubilee Regent in 1944. In 1963, in her 75th year, she wrote the Chapter's History, which was destroyed by the Roanoke River when it flooded the Chapter's Memorabilia Trunk in the bank's basement vault on November 4, 1985. But fortunately she had saved a copy at her home, "Paradise II", at 2723 Crystal Spring Avenue, S. W.

The group is the oldest DAR Chapter in Roanoke, and the fifth oldest in Virginia. It was organized in 1894 by Mrs. Lelia Maria Smith Cocke, its first Regent, or President, and was named for the Mother of Revolutionary War General Andrew Lewis of Salem, Virginia.

Mrs. Kitty Darnall Shank was the Regent last year when this Medallion of Honor project was initiated by the Chapter; and Mrs. Betty Brockway Low is the present Regent at its conclusion.

58 men and women attended the October Dedication Ceremony, 24 men and 34 ladies, on that providentially warm, sunny Friday afternoon, between two rainy spells; unfortunately, some of her friends were out of town and missed it. Guest soloist was John Easter Wimmer, possessor of a God given baritone voice. "Jack" sang: America, My Country 'Tis of Thee, for this patriotic occasion. He is a long time friend of the Honoree's son, Hoskins M. Sclater, Esquire, pronounced Slaughter.

Because Hoskins' Mother was even more active in volunteer church work, on local Presbyterial and Synodical levels, he chose to stand between the two Associate Ministers of their Second Presbyterian Church: Dr. Taylor Todd and Rev. Stephen Emick. The Senior Minister, Dr. William Klein, had conducted her graveside funeral service. In the days following her death on May 23, 1991, her son received over 400 expressions of love for her and sympathy for himself. She was blessed with an alert mind and a cheerful personality until the moment of her death, while sitting up in her old four poster bed at her home just after supper. She had reached 102½ years of age, Deo gratias, (Thanks to God).

MARGARET LYNN LEWIS (Roanoke, VA) dedicated its bronze DAR Insignia Marker, mounted on a 9-inch square stone, on Friday, October 2, 1992 in Evergreen Cemetery, Roanoke, at the grave of: (Mrs. R. Hoskins) Anne Richardson Sclater, a native of Farmville. She was its Golden Jubilee Regent in 1944 during her term 1943-46. The President General and the State Regent attended the Golden Jubilee Tea in nationally famous Hotel Roanoke!

In 1963, in her 75th year, she wrote the chapter's History. The group is the oldest chapter in Roanoke, and the fifth oldest in Virginia. It was organized in 1894 by Mrs. Lelia Maria Smith Cocke, its first Regent, and named for the mother of Revolutionary War General Andrew Lewis of nearby Salem. Mrs. Kitty Damall Shank was Regent last year when this Grave Marking project was initiated by the chapter; Mrs. Betty Brockway Low is now Regent at its conclusion.

Fourteen ladies and 24 men attended the dedication ceremony. Because Mrs. Sclater (pronounced Slaughter) was even more active in volunteer church work, on local, Presbyterian and Synodical levels, her son had their two Associate Ministers of Second Presbyterian Church stand beside him at the dedication ceremony. The Senior Minister had conducted her graveside service following her death on May 23, 1991 at age 102½.

She was blessed with an alert

mind and a cheerful personality until the moment of her death.



Breaking barriers

MOTIVATION is great, but can you imagine a class that continues to meet weekly, without credit, during the summer; registers to repeat the same class two or three times in succession; and forms friendships that span at least a decade?

Several members of the Virginia Western Community College German class taught by Delores Groening Moore met recently to reminisce about their unusual scholastic adventure. It's difficult, if not impossible, to determine who was enrolled for the longest time. Like Topsy, the class just grew. Husbands brought wives and wives brought husbands; friends told friends, and soon a group of approximately 20 students was spending four hours each week mastering the intricacies of a foreign language.

Summer came and the class ended. Moore did not wish to teach during the vacation months, but she joined the group "for fun" as they continued their weekly sessions.

Time travels bring family history to life

The 13 pupils in Tim Moser's fifth-grade social-studies class at Highland Park Elementary School listened eagerly as Betty Jane Brockway Lowe explained the long process involved in tracing a family

tree.

"When I first started going to Washington, D.C., to the National Archives, there may have been a half-dozen people there, and when you asked for documents, the workers would bring out big, brown envelopes with the original letters or records in them, often with crumbling

edges and smelling of age.

"Now, there are rows and rows of people working on their genealogies. Most of what you need is on microfilm, and a great deal of work has been done to compile indexes, so the search is easier."

Lowe's presentation was the final touch on their unit of history

available to seek an answer.

"My church offered an adult class in genealogical research, and I found out how to use an outline to get things sort of organized. It began as a very interesting hobby. I was never able to devote large blocks of time to it," Lowe said.

It took time and miles that included trips to courthouses in Virginia, Connecticut, Pennsylvania and hours in the Library of Congress archives in the nation's capital. It also included many, many visits to the Virginia Room of the Roanoke Public Library before pieces began to fall into place.

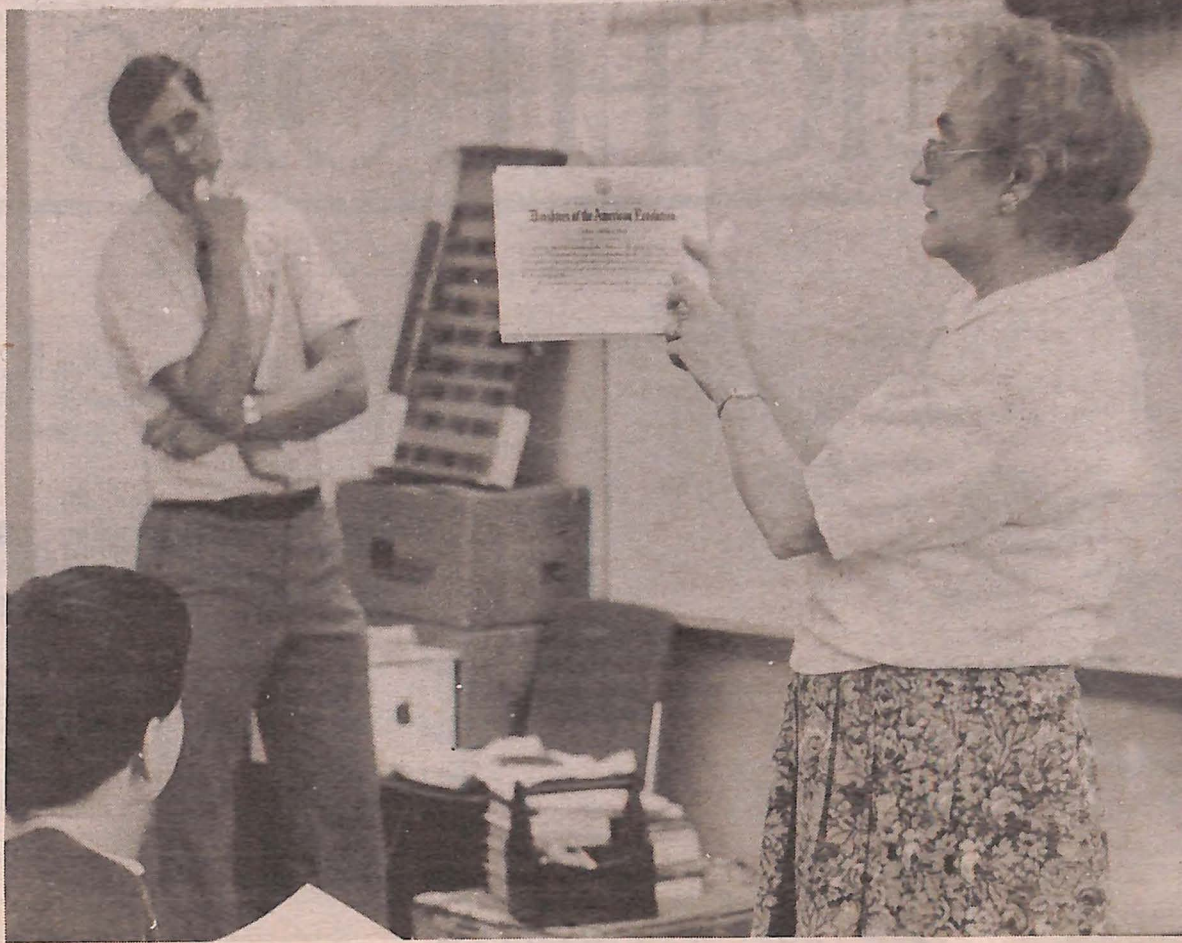
After about 11 years, Lowe found two relatives, one from Lyme, Conn., and the other from Elizabethtown in Lancaster County, Pa., who had been enlisted men during the American Revolution.

Moser said, "She added a touch we wouldn't have gotten otherwise. The children were quite surprised to learn that you can't take books out of the Virginia Room. It's little things like that we overlook sometimes in teaching."

Moser's pupils also began to grasp the notion of generations, generally accepted as 20 years but lengthening these days as people live longer. Lowe tracked back 330 years to 1659 when her family arrived in the colonies from England.

"The first census in America was taken in 1790, and records make it a little easier to trace people after that," Lowe said. "Before the census, you have to find marriage licenses, court records, real-estate transfers, death certificates, all kinds of documents, many of them fragile with age, all handwritten."

She brought to class copies of two pages, one an appeal from Benjamin Brockway, her Connecticut relative, asking for a pension as a result of being wounded in the Battle

of Long Island in August 1776. The appeal was filed in 1818 when Brockway was 67 years old and had fallen upon hard times.

The other was a deposition filed in Wythe County by Peter Eversole, the Pennsylvania relative, reporting that he had joined "shortly before harvest in 1777."

Preservation of such documents has been a major project for the Daughters of the American Revolution throughout America, and Lowe

has joined the DAR principally because she was so impressed with the scope of their efforts.

Lowe emphasized that Americans have been travelers ever since this continent was discovered. "I found part of my seafaring family tucked up deep in the Virginia mountains in Bath County."

Following her talk, the classroom exploded with questions and comments. Children had heard their own families talk about Gen. Francis Marion, "The Swamp Fox" from South Carolina, about the naval hero John Paul Jones, and even the hapless Gen. Braddock.

"Have your family write down the things they know or have heard, and then you can start your own

search," Lowe encouraged. "It took many, many brave and strong people to build this country. Some of them belong to you."

The Highland Park class was the first audience Lowe had ever faced. "I was really nervous," she said later. "Even though I taught school years ago, I never dealt with elementary students. This program was a special request. I may never do it again."

The day was closing for school. Yet, around the room, there was talk about how hard it must have been to walk from Yorktown to Pennsylvania, or questions about the height of a shot-tower, and the awesome pain of wounds treated without the help of modern painkillers.

In Christian church work she was President of the Women's Auxiliary of Second Presbyterian Church, Roanoke (1931-1933); Treasurer of Montgomery Presbyterian; and a member of the Virginia Synodical Board. She disapproved of the liberalism and modernism that gained considerable influence over her Southern Presbyterian denomination in the 1970's. In civic affairs she was the Golden Jubilee Regent (1943-1946) of Roanoke's oldest D.A.R. group: the Margaret Lynn Lewis Chapter; a charter member of Farmville's Judith Randolph Chapter, D.A.R.; an honorary life member of Farmville's U.D.C.; and President of the Women's Club of Big Stone Gap, Virginia, where three Sclaters lived from 1924 to 1927. Her parents were George Richardson (1855-1946) and Alice Holman (1859-1954), of Farmville, Virginia, through whom she descended from some of the old Southside families of Prince Edward, Cumberland, Charlotte and Buckingham Counties. In 1937-1938 she and Dr. J. Kirk Richardson published in The Virginia Magazine of History and Biography, an article on the Richardson Family. Her father's bachelor, half-brother was Colonel Robert A. Richardson of the Confederacy, later a judge on the Supreme Court of Appeals of Virginia. Her father's mother was Elizabeth A. Rives, first cousin to U.S. Senator William C. Rives of Virginia, twice Ambassador to France and grandfather of Princess Amelie Rives Troubetzkoy, a gifted Virginia novelist. In 1907, Mrs. Sclater graduated from State Teachers College (now Longwood) in Farmville (across the street from the Richardson home). Then she taught near Hampton and in Roanoke prior to her marriage in 1916 to R. Hoskins Sclater, who died on May 12, 1973 in his 90th year. His parents were John Mallory Sclater (1848-1915) and Mary Simkins (1855-1866) of Hampton, Virginia. The Reverend James Sclater of Oxford, England, had established the family in nearby York County, Virginia in the 1600's. Sclater is English and is pronounced the same as Slaughter. Mrs. Sclater is survived by an only child, Dr. Hoskins Mallory Sclater, B.A.-B.S.-J.D., a retired lawyer; and by one sister, Mrs. Virginia Richardson Pollard, of Winston-Salem, North Carolina; her older sister, Miss H. Fundamental law is under attack

THE SUPREME Court has ruled 5-4 that school prayer and prayers at school graduations are unconstitutional. Freedom of speech and action concerning religious expression and tradition have been attacked. The old traditions that have existed in our nation for many years are no longer acceptable to those who seek to change our laws.

New laws are being invented to take the place of those on which our nation was founded. A state of rebellion exists toward our constitutional laws by those in su-

preme authority.

The Constitution of the United States of America went into effect March 4, 1789. It is the supreme fundamental law of the United States of America, by which all powers of the national government are established and limited.

The First Amendment to the Constitution says: "Congress shall make no law respecting an establishment of religion or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances." The rest of the first 10 amendments guarantee other rights, such as strict legal justice.

Freedom in the sense of negative action is now acceptable, but freedom of positive action is not. For example: It is now permissible to burn a cross on the property of a citizen or neighbor, because to curtail such action would deprive persons of free expression.
